Is the holder of a Personal Accidents policy n° **ADP20161007**.

This policy covers any person having booked a trip in **Belgium, Italy, Sweden** as a passenger via the mobile application HEETCH of the Subscriber, ***excluding passengers of classified 'professional' drivers having provided proof of specific insurance adapted to these paid passenger transport.***

**SCOPE OF COVER:** The coverage is granted during booked trips, **only** when the person is a current passenger of the vehicle (stopped or in traffic), also when the passenger takes place in the vehicle or when the passenger gets off, **but exclusively** during the travel booked on the HEETCH app.

**Total Permanent Disability : Euros 500.000**

Reducible in case of Partial Permanent Disability according to the scale company with a relative deductible of 10%

**Any covered accident resulting in a Partial Permanent Disability of less or equal to 10% shall not give rise to payment of any benefits.**

**But for any disability of more than 10%, no deductible shall be applied.**

**Daily compensation in case of coma :**

If, following an Accident, and without prejudice to the exclusions provided, an Insured is in Coma during a uninterrupted period of more than 10 days, the Insurer will pay a benefit of Euros 50 per day, from the tenth day of coma and during a maximum period of 365 days.

**HEETCH Solidarity**

In case of bodily injuries that lead to an hospitalization, the Insurer will pay 30 trips booked on the HEETCH app., in the limit of an amount per travel equivalent to the occurrence trip.

Trips shall be booked within 12 months following the Accident.

**PERIOD OF COVER:** from 2017/01/01 up to 2017/12/31

This Insurance Certificate does not bind the Insurer beyond the limits specified by clauses and conditions of the policy referred above.
